

RESOLUTION 2006–09

**AMENDING THE CENTRAL LANE METROPOLITAN PLANNING ORGANIZATION
FY2005-2007 METROPOLITAN TRANSPORTATION IMPROVEMENT PROGRAM**

WHEREAS, the Lane Council of Governments (LCOG) Board has been designated by the State of Oregon as the official Metropolitan Planning Organization (MPO) for the Central Lane region; and

WHEREAS, the LCOG Board has delegated responsibility for MPO policy functions to the Metropolitan Policy Committee (MPC), a committee of officials from Eugene, Springfield, Coburg, Lane County, Lane Transit District, and ODOT; and

WHEREAS, federal regulations require the Metropolitan Planning Organization to adopt a long-range regional transportation plan consistent with guidelines set forth by the Federal Highway Administration and the Federal Transit Administration; and

WHEREAS, federal regulations require that transportation projects using several categories of federal funds and projects that are regionally significant for air quality purposes be included in a Metropolitan Transportation Improvement Program (MTIP); and

WHEREAS, 23 CFR §450.324(b) requires that the MTIP be updated every two years and be kept current to reflect decisions regarding the programming of federal funds; and

WHEREAS, the MPO Policy Board (MPC) adopted an Air Quality Conformity Determination for this MTIP on December 30, 2004; and

WHEREAS, the proposed amendments set forth in Exhibit A do not affect the existing air quality conformity determination or trigger the need for a new air quality conformity determination.

NOW, THEREFORE, BE IT RESOLVED:

That the Metropolitan Policy Committee amends the FY2005–2007 Metropolitan Transportation Improvement Program, as set forth in Exhibit A, attached to and incorporated within this resolution by reference.

Program \$40,000 in federal Surface Transportation Program – Urban (STP-U) funds in FY07 for the City of Eugene for *Regional Transportation Planning*.

Program \$40,000 in federal Surface Transportation Program – Urban (STP-U) funds in FY07 for the City of Springfield for *Regional Transportation Planning*.

Program \$25,000 in federal Surface Transportation Program – Urban (STP-U) funds in FY07 for Lane County for *Regional Transportation Planning*.

Program \$15,000 in federal Surface Transportation Program – Urban (STP-U) funds in FY07 for the City of Coburg for *Regional Transportation Planning*.
