Subject: Item 4b: Draft FY05-07 Metropolitan Transportation Improvement Program (MTIP)

**Action Requested:** Hold public hearing on *Draft FY05-07 Metropolitan Transportation Improvement Program (MTIP)*

## Background

At the October 9, 2003 MPC meeting MPC adopted the FY2004-06 Central Lane MTIP. The MTIP lists transportation projects using federal funds programmed for fiscal years 2004-2006. The MTIP also lists all non-federal funding sources for individual projects. Since that adoption, both the Transportation Planning Committee and MPC have adopted a number of administrative and non-administrative amendments to the MTIP.

At the November 18, 2004 MPC meeting the *Draft FY05-07 Metropolitan Transportation Improvement Program* was distributed. MPC discussed the draft MTIP and a motion to release the draft for public review failed 5 yes:1 no vote due to the lack of an affirmative vote from at least one Eugene MPC representative.

## Draft FY05-07 Transportation Improvement Program

Attachment 1 is an annotated project list from the *Draft Central Lane TMA FY2005-2007 MTIP* showing changes from the FY04-06 MTIP. The MTIP contains a three-year listing of anticipated expenditures for funded projects drawn from the capital improvement programs of Eugene, Springfield, Coburg, Lane County, Lane Transit District, and ODOT. In addition, the MTIP lists projects for which application of specific federal funds will be made in the next three years, to the extent that is known at this point. The project list is essentially unchanged from the list included in the draft distributed at the November MPC meeting. This new annotated version was prepared to facilitate clear understanding of the project programming actions proposed in the FY05-07 draft.

## Public Comment

A *Preliminary Draft FY05-07 MTIP* was available to the public at the time of the November 4, 2004 public open house. A second open house was held December 1<sup>st</sup>. In addition, MPO staff sent email and postal mail notices of the public comment period, the open houses and the public hearing scheduled for December 9<sup>th</sup> to a distribution list of interested parties.

At the two open houses, approximately twenty to twenty-five citizens participated in reviewing the RTP, the MTIP and air quality, as well as other regional transportation issues. To date, MPO staff has not received any specific comments from the public regarding the draft MTIP. Any comments provided between the date of this memo and the date of the MPC meeting will be handed out at the meeting.

## Next Steps

As shown in the table included as Attachment 2, as of the conclusion of the December 9<sup>th</sup> MTIP public hearing, the MPO will have fulfilled all of the federal requirements for updating and adopting the MTIP, short of actual adoption.
